- 申請本人戶口必須已登錄滿 2 年或以上及沒有銷售及沒有佣金 2 年或以上。 Applicant's ID must registered 2 year or above and no sales and commission 2 years or above.
- 如擁有多個同名 ID，或直系親屬 ID，其 ID 需要一併申請取消，每個 ID 手續費 HK\$500。 Distributor with multiple ID, and direct related family ID, all need to terminate, Handling charge per ID HK\$500.
- 申請本人必須自行電郵申請表到 compliance@enagic-asia.com，同時提交附有相片的身份證明文件，等法規部約見。 Applicant must submit the application and picture ID to compliance@enagic-asia.com by email, and wait for Compliance Department notice for meeting.
- 收到申請後公司會通知申請人之介紹人，6A 及 6A2-3 了解情況。 After receive application will inform direct sponsor, 6A and 6A2-3 leader.
- 申請本人必須參加 1A~5A 培訓及考試合格。 Applicant must join 1A~5A Training and pass the test.
- 批准 FA 申請後，FA 申請人轉往其他團隊時，其下團隊不會一併轉移，舊 ID 及其分銷權會被取消，需要購買一台重新登錄為分銷商。 The FA distributor will be the only one to change lines and their down line shall NOT be moved, and their previous ID number shall be invalid. The FA distributor purchase one unit machine to register as distributor.
- 特例分銷商不能申請 FA，需要解除特例後才能申請 FA。 Tokurei distributor is prohibited from making FA line changes until they have cancelled their Tokurei and paid off their machines.
- 薑黃 DD, E8PA 卡，會員價之 ID 不能申請 FA。 Ukon DD, E8PA card, or machines with member prices cannot be a FA.
